

ARTICULATION AGREEMENT
between
Norwich University and Fayetteville Technical Community College

I. PURPOSE

The purpose of this Articulation Agreement is to acknowledge that students of Fayetteville Technical Community College may transfer to the Norwich University Bachelor of Science in Strategic Studies and Defense Analysis (SSDA) program following completion of an associate's degree program at Fayetteville Technical Community College.

II. ELEMENTS

1. To be eligible for application to enroll the student must submit proof of having been awarded an associate's degree from Fayetteville Technical Community College in the form of an official transcript from Fayetteville Technical Community College.
2. Students who complete the Associate's in General Education degree or another Associate's degree program consisting of a minimum of 60 semester credits will be eligible for a block transfer of 60 semester credits earned as degree credits and acceptance into the Strategic Studies and Defense Analysis baccalaureate program at Norwich University. Credits earned in excess of 60 semester credits will be evaluated on an individual basis for transfer into specific requirements of the baccalaureate program.
3. Credit earned through any combination of Transfer Credit, Challenge Credit or Experiential Credit will not exceed 75-percent of total credits required for the Fayetteville Technical Community College associate's degree. Credits from military training used to complete requirements for a Fayetteville Technical Community College associate's degree may not be applied toward courses in the Bachelor of Science in Strategic Studies and Defense Analysis if it is included in the block transfer of credit as part of this agreement.

III. TERMS

1. Because of this agreement to articulate, Norwich University will extend professional courtesy discounts to Fayetteville Technical Community College employees concomitant with the date of this fully executed document.
2. Fayetteville Technical Community College alumni and employees will receive a ten (10%) percent discount on their tuition to online degree programs offered by Norwich University at regular tuition levels; programs offered at military tuition assistance levels are not subject to the discount. Fayetteville Technical Community College employees must inform Norwich University admissions representatives about their affiliation to receive their discount;
3. Norwich University will extend to Fayetteville Technical Community College alumni and employees all of its online certificates, undergraduate, and graduate programs, as and when offered;

IV. This Agreement is effective as of the date of the fully executed document, and shall continue until terminated. Both parties must approve amendments to the Agreement in writing.

1. Once a year, Norwich University will provide a report on students to Fayetteville Technical Community College. The report, on Norwich's letterhead, will include names of Fayetteville Technical Community College alumni. The report will state "The below students from Fayetteville Technical Community College have transferred to Norwich University, have completed at least three terms and are making satisfactory academic progress through their program (as defined in the Norwich University catalog)."
2. Either party may terminate the Agreement without cause upon 90 days written notice to the other party. Notwithstanding the foregoing, either party may terminate the Agreement immediately in the event that participation under the Agreement may give rise to a violation of any requirement of federal or state law or regulation or the requirements of any accrediting agency having jurisdiction.
3. Admission criteria, academic requirements, and other admission requirements will be subject to the applicable Catalog at the time of the students' admission to the Strategic Studies and Defense Analysis program. Students who have begun their Fayetteville Technical Community College program of study or students in the process of enrolling prior to the effective date of any without cause termination will be grandfathered in to continue receiving the discount offered in this Agreement until such time such students complete or discontinue enrollment in their program.
4. The parties grant to each other a non-exclusive, non-transferable license to use each other's trademarks and servicemarks in furtherance of the articulation coordination detailed herein or in a manner solely for the purpose of identifying and communicating the existence of the relationship to Fayetteville Technical Community College students and alumni. Use of trademarks, servicemarks and logos will comply with use policies of the originating institution. The parties shall discontinue the use of the licensed marks and return any and all files and materials containing the licensed marks supplied by the owner at termination or expiration of the Agreement. Neither party grants to the other any interest in the other party's trademarks. Should either originating institution request, in writing, that a particular use of the originating institution's trademarks and/or servicemarks be discontinued, the non-originating institution shall cease and desist such use of the trademarks and/or servicemarks.
5. The parties hereto will have the relationship of independent contractors for all purposes. Each will have complete control over its own performance and the details for accomplishing its own obligations under this Agreement. In no event will the agents, representatives or employees of one party be deemed to be agents, representatives or employees of the other.
6. This Agreement may be executed by a duly authorized representative of each party, either by electronic or facsimile transmission, each of which will be considered an original.


