PAYMENT DUE DATES and CASHIER SCHEDULE

Payments for registrations made **August 29th – October 3rd** are due by **5 p.m. on Monday, October 3, 2016.**
 Payments for registrations made **October 4th – October 11th** are due by **5 p.m. on Tuesday, October 11, 2016.**
 Payments for registrations made **October 12th** are due by **4 p.m. on Wednesday, October 12, 2016.**
 Payments for registrations made **on/after October 13th (for Nov. 1th classes)** are due **4 pm, October 31st.**

NOTES: If you do not pay according to these due dates, you are subject to having your courses dropped for non-payment.

- **Awarded Financial Aid constitutes payment and will hold your courses if you meet FA eligibility requirements.**
- **Enrollment in the Tuition Payment Plan constitutes payment and will hold your classes.**
- **Third Party Authorizations must be filed with the Cashier's Office by the due dates listed above.**

To avoid being charged tuition and fees, it is your responsibility to confirm that your classes have been dropped prior to the first day of the semester/term by checking your WebAdvisor account.
